**Job Description:** This position will direct and oversee all aspects of the Women's Golf Program. The golf program is expected to recruit student-athletes that can be successful academically, socially, and athletically at CSUB, schedule and coach intercollegiate matches and tournaments, counsel the student-athletes on academic, athletics and social issues, build and maintain positive relationships with team, University population and the public; and monitor the team budget.

## **Minimum Qualifications:**

- Two (2) Years of collegiate coaching experience
- Bachelor's Degree
- Demonstrate teamwork and team building skills
- Demonstrate priority setting and organizational skills
- First Aid/CPR Certification

## **Preferred Qualifications:**

- Master's Degree
- Four (4) years of collegiate coaching experience
- Coaching or competitive experience at the Division I level
- Knowledge of Division 1 compliance with the Policies and rules of the University, NCAA, and the Big West Conference
- Demonstrated success in ability to successfully recruit student-athletes.
- Demonstrated success in ability to fundraise.

**Background Check**: A background check (including a criminal records check) must be completed satisfactorily before any candidate can be offered a position with the CSU.
