INFORMATIONAL ITEMS.

1. **Notification of Transfer Windows Discussion.** The Football Bowl Subdivision Oversight Committee discussed NCAA Division I Proposal No. 2023-36 (RECRUITING AND ACADEMIC ELIGIBILITY -- NOTIFICATION OF TRANSFER WINDOWS -- REDUCE FROM 60 DAYS TO 30 DAYS).

The committee expressed initial support for a football bowl subdivision transfer window model that:

- a. Establishes a uniform start date for the written notification of transfer process to begin the Monday following the second Saturday in December (Monday following FBS conference championship weekend);
- b. Considers the impact of the early National Letter of Intent signing period; and,
- c. Consists of three notification of transfer windows (e.g., December, January, April).

During its review of Proposal No. 2023-36, the committee recognized the combined impact of the notification of transfer windows, the National Letter of Intent signing periods, coaching changes, variations in academic calendars and the one-time transfer exception on the recruiting process. Additional discussion about football's National Letter of Intent signing dates may be necessary to minimize the impact the notification of transfer windows and NLI early signing period have on postseason football contests.

The committee agreed to solicit feedback from their respective constituents before the October 2-3, 2023, in-person meeting and expects to finalize a recommendation to the Council during those meetings.

2. **Approve NCAA Division I Football Oversight Committee July 20, 2023, report.** The NCAA Division I Football Bowl Subdivision Oversight Committee approved the July 20, 2023, report.
